

Area Vice President of Sea Scouting

Qualifications:

- Be a registered Sea Scout in a council within the Southern Region
- Be recommended or approved by his or her council
- Be less than 20 years of age on June 1, 2015

Responsibilities:

- Serves as Vice-President of Sea Scouts within the Area VOA
- Advises the SR VP of Sea Scouts of Sea Scout activities and events happening within their area
- Represents their respective Area at Sea Scouting events (when designated)
- Represents their respective Area at other Scouting events (when designated)
- Serves on other Special Projects, Programs, or Activities as designated by their Area President
- Promotes national, regional, and area Sea Scouting and Venturing activities, programs, and awards
- Agrees to resign from office if requested to do so by the regional staff or area leadership

Term of Office:

The Area Vice President of Sea Scouting will serve from June 1, 2015 through May 31, 2016.

Action:

Councils should approve and forward the attached nomination form to the selection committee by May 15th, 2015. The selections will be made known by May 31st, 2015.

Additional Information:

The nominee should attach no more than two 8.5 x 11 inch pages on white paper to this nomination stating his or her qualifications for the Area Vice President of Sea Scouting position. These pages should include:

- a. Experience as a Ship or Council Boatswain
- b. Experience as the chairperson or other officer of your council's Venturing Officer's Association, Teen Leader Council, or similar council level organization
- c. Leadership experience, awards, training, and other activities related to Sea Scouting and/or Venturing
- d. Honors, leadership positions, awards, and training from church, Scouting, or other organizations
- e. School awards, clubs, sports, scholarships, and leadership positions
- f. A statement on college or career plans
- g. A brief statement on why you want to be an Area Vice President of Sea Scouting
- h. Other information on your qualifications for the position
